Avantidrome Bike Storage Agreement

1. Avantidrome Bike Storage – Terms and Conditions

- a) All bike storage is subject to availability. If at the time of completing the Hire Form there are no available bike hooks for hire you will be placed on a waiting list.
- b) The period of hire is annually from 1st April to 31st March the following year. A pro rata calculation (weekly) will be used to calculate the first year to bring a new hirer into line with the annual fee structure.
- c) An invoice will be sent to you for the hireage for the following year. This is to be paid by the 20th March each year.

2. Hirer's - Terms and Conditions

- a) You are responsible for ensuring that your bike is stored on the correct hook at all times. Each hook is numbered and you will be required to store your bike on only that numbered hook.
- b) Only track bikes can be stored in the storage facility. This does not extend to helmets, track shoes, gearing bags and other bags containing clothing or equipment.
- c) By using the Avantidrome storage facility you accept that the facility is open to other riders who have hired a hook. The Avantidrome does NOT monitor the bike storage facility.
- d) It is the sole responsibility of the hirer to ensure their bike is appropriately secured to reduce the risk of theft.
- e) Access to the bike storage area is granted on the express condition that the Avantidrome shall under no circumstances be liable or responsible in any manner whatsoever and the hirer agrees to indemnify the Avantidrome for:
 - Any loss or damage to property which is retained within the storage facility
 - Any loss, accident, damage or injury to the hirer in using this storage facility
- f) The Avantidrome reserves the right to move, relocate or impound any bike that appears to be neglected and the owner has failed to return to collect the bike at the end of the storage period. The Avantidrome will endeavor to make every possible action to inform the bike owner and hirer of the expiry of their hire period before taking such actions.
- g) The Hirer will ensure that the bike storage area is always locked on their departure. The door must not be wedged open.
- h) The Hirer will not claim or obstruct another hook in the storage facility.
- i) The Hirer will treat other person's bikes with respect, and will not touch or move them unless necessary and in the first instance will be required to contact staff at the Avantidrome to move said bike.
- j) If the Hirer does not renew the Hire Agreement by paying the full amount for the following year by 20th March, this will be deemed by the Avantidrome that you do not wish to continue the storage and your hook may be hired to another person.
- k) After the expiration or cancellation of the Hire Agreement, then the Hire Agreement will be deemed expired and the Avantidrome has the right to impound or remove the bike from storage. If the bike is not claimed by the original hirer after 6 months passed the expiration date, then the bike will be sold and monies collected will pay for the additional storage period.
- l) Persons who do not comply with the Terms and Conditions of Use will be issued a notice that their Hire Agreement has been terminated. Those persons will have 14 days from the date of the notice, or such time specified in the notice, to remove their bike from the storage facility, after which time the bike will be impounded.
